FINANCING YOUR STUDIES

Student-BAföG

Students of the SRH Hochschule Berlin at the Campus Dresden have the opportunity to receive financial support from the German government. BAföG, which is state funding program for students, can be awarded to international students in exceptional cases. You can get information from the BAföG advisory service at the studierendenWERK Berlin.

Requirements to get "BAföG" as foreigner:

- one parent has the German citizenship
- you have or have had a German spouse
- you are a legitimate asylum seeker, stateless or a refugee
- one parent was legally employed in Germany for three years within six years before the beginning of studies, or
- you were legally employed in Germany for five years before the beginning of studies

Scholarships

Various public, private und charitable institutions offer support and scholarships for students. On webpages like www.stipendienlotse.de, www.mystipendium.de oder www.e-fellows.net you have access to different scholarship databases.

SRH Scholarships - 8forYou

SRH Hochschule Berlin is awarding 8 performance scholarships to the participants of the scholarship competition 8forYou. The competition is aimed at applicants who will start their studies - Bachelor's, Master's or MBA - in winter semester in Berlin or Dresden. The participants who convince with their creativity and performance will benefit from a 300 EUR decrease in their monthly tuition fees. Initially, the scholarship is only granted for one year. If the scholarship holder maintains a grade point average of 1.5 (or better), the scholarship grant will be extended for one year at a time. Applications are possible until 31st July. Deutschlandstipendium

The Deutschlandstipendium is an initiative of the federal government for supporting talented students. It is modelled after the principle of public-private partnerships, businesses, foundations or private individuals sponsor young talents with a pledge of 150 EUR per month. The Federal Government matches this amount with another 150 EUR. The total of the scholarship adds up to 300 EUR per months und will be granted for a minimum of 12 months. ERASMUS+

ERASMUS+ is the name of an European action program which supports one or two semesters and internships abroad. There is the chance to receive financial support during an compulsory or voluntary internship (duration of a minimum of 2 months and a maximum of 12 months) with a subsidy up to 700 EUR per month. Student loan

The student loan is a low interest loan from the government for the purpose of supporting students during higher education. It is granted for a maximum of 24 months and amounts up to 300 EUR per month. It can be used in addition to the BAföG payments. Repayment begins four years after the first payment of the loan. However, student loans are only limitedly available to international students. The conditions are equivalent to BAföG. For more informations please contact studierendenWERK Berlin. A further option is a student loan at a bank that offers special educational loans and student loans with low interest rates to students.

Part-Time-Job

Many of our students finance their studies with a part-time-job. On one hand you earn some money and on the other hand you gain experience, which is a win-win situation. Depending on your country of origin you can either only earn less than 450 EUR per month. In this case the employer will pay your taxes and you earn the full 450 EUR. As a student you do not have to pay income tax and social security contributions. If your monthly income exceeds 450 EUR you only have to pay for pension contribution. Be aware, if the earnings exceed 450 EUR the amount of the BAföG funding will be affected. More information on www.deutsche-rentenversicherung.de
